

Introduced by Treece Council Bill No. R 42-17

A RESOLUTION

setting a public hearing; declaring the necessity for proposed construction of speed tables and the installation of speed humps and crosswalks on Stewart Road, between West Boulevard and Garth Avenue; stating the nature of and the estimate of the cost of the proposed improvement; providing source of funds for payment for the proposed improvement; and providing for compliance with the prevailing wage law.

WHEREAS, interested parties meetings for the proposed construction of speed tables and the installation of speed humps and crosswalks on Stewart Road, between West Boulevard and Garth Avenue, was held by the Public Works Department on November 16, 2016 and February 8, 2017.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. A public hearing in respect to the proposed public improvements set forth herein will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on May 1, 2017. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.

SECTION 2. The City Council deems the proposed construction of speed tables and the installation of speed humps and crosswalks on Stewart Road, between West Boulevard and Garth Avenue, necessary to the welfare and improvement of the City. Specifically, the proposed improvements include:

- Construction of speed tables at the intersection of Stewart Road and Lindell Drive and Stewart Road and Westwood Avenue; and
- Installation of a speed hump on Stewart Road east of Edgewood Avenue and the installation of a speed hump on Stewart Road east of West Parkway Drive/Westmount Avenue; and
- Installation of a crosswalk on Stewart Road east of Edgewood Avenue, installation of a crosswalk on Stewart Road west of Glenwood Avenue, and installation of a crosswalk west of West Parkway Drive/Westmount Avenue.

SECTION 3. The nature and scope of the proposed improvements shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 4. The estimated cost of the proposed improvements is \$31,800.00.

SECTION 5. Payment for the proposed improvements shall be made from annual traffic calming funds and such other funds as may be lawfully appropriated.

SECTION 6. Any work done in connection with the construction of the proposed improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.
