AN ORDINANCE

amending Chapter 17 of the City Code as it relates to Parks and Recreation fees; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 17 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 17-161. Fees.

(a) *Activities/classes.* Any activity (unless specified elsewhere in this section) that has as its main objective to instruct a participant for the purpose of increasing the participant's skill level, will carry a fee of:

Children (17 and under).....	\$3.00—\$100.00 <u>150.00</u>
Adults	3.00—175.00 <u>225.00</u>

The fee for each individual class is based upon the recovery of direct costs associated with the program.
