

Introduced by Treece Council Bill No. R 140-20

A RESOLUTION

setting a public hearing; declaring the necessity for the proposed replacement and improvement of public storm drainage infrastructure adjacent to the intersection of Hickman Avenue and Sixth Street; stating the nature of and the estimate of the cost of the proposed improvement; providing source of funds for payment for the proposed improvement; and providing for compliance with the prevailing wage law.

WHEREAS, interested parties meetings for the proposed replacement and improvement of public storm drainage infrastructure adjacent to the intersection of Hickman Avenue and Sixth Street was held by the City Utilities Department – Sewer/Stormwater Division on January 28, 2020 and October 13, 2020.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. A public hearing in respect to the proposed public improvements set forth herein will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on November 16, 2020. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.

SECTION 2. The City Council deems the proposed replacement of approximately 300 to 400 feet of reinforced concrete box (RCB) and the improvement of approximately 200 feet of storm water pipe and ten (10) inlets adjacent to the intersection of Hickman Avenue and Sixth Street, necessary to the welfare and improvement of the City but desires to hear from the public prior to taking further action to authorize construction of the project. Possible alignment options and the estimated costs for the proposed public storm drainage infrastructure improvement project are as follows:

Alignment 1:

Purchase and removal of the Center Project building located at 515 Hickman Avenue and the existing fencing and tree on the property site in order to increase overflow capacity. The construction area for the storm water structures will be primarily within the existing right-of-way areas of Sixth Street and Hickman Avenue. The estimated cost for Alignment 1 is \$745,000.00, exclusive of property acquisition and demolition costs.

Alignment 2:

Deep excavation of poor soils on the Jefferson Middle School property adjacent to Hickman Avenue along with the construction of an additional RCB structure on the school property and the lowering of the Sixth Street and Hickman Avenue intersection to improve

the storm water overflow path and capacity. The estimated cost for Alignment 2 is \$935,000.00, exclusive of easement acquisition.

SECTION 3. The nature and scope of the proposed improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements. Following the public hearing the City Council shall determine whether it is in the public interest to make the proposed public improvements or any part thereof.

SECTION 4. The estimated cost of this proposed improvement project is \$1,100,000.00.

SECTION 5. Payment for this proposed improvement project shall be made from Storm Water Utility funds and such other funds as may be lawfully appropriated.

SECTION 6. Any work done in connection with the construction of the proposed improvement project specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.
