Re: Authorizing the acquisition of easements for the replacement and improvement of public

storm drainage infrastructure on Alan Lane, Boyd Lane, and Oriole Lane

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the acquisition of easements necessary for the replacement and improvement of public storm drainage infrastructure on Alan Lane, Boyd Lane, and Oriole Lane; Location Map attached. At the public hearing on February 20, 2023, Council authorized the project to proceed.

Discussion

Alan Lane Stormwater Improvement Project, as shown in the attached Project Graphic, will consist of constructing approximately 700 feet of new stormwater pipe and ten (10) stormwater structures.

This project will require the acquisition of seven (7) permanent drainage easements and ten (10) temporary construction easements from ten (10) parcels/property owners. See the attached Easement Project Graphics for individual diagrams of the proposed easements to be acquired.

The existing stormwater system at Boyd Lane and Oriole Lane is in poor condition and there is yard and street flooding. The public system drains to a private, failing storm drain, limiting the City's ability to effectively manage and maintain the storm drainage system. Additionally, at Alan Lane and McKee Street, the property at the southeast corner of the intersection (1612 McKee), takes on stormwater from the south and east. The upstream drainage area has increased impervious area due to developed, causing an increase in the stormwater entering the backyard and causing flooding to the garage. The proposed improvements will address both of these issues. The proposed pipe alignment in Boyd Lane will be within the street pavement per Council direction at the public hearing.

Construction plans are 90% complete, with construction expected in 2024, pending acquisition of these easements. The resolution estimate for this project is \$67500,000 to be paid from Storm Water Utility funds.

Fiscal Impact

Short-Term Impact: The resolution estimate is \$6750,000.

Long-Term Impact: Minimal impact on the Storm Water Utility's annual operating cost.
