### **Executive Summary**

Staff has prepared for Council consideration a resolution authorizing the City Manager to execute an aviation project consultant supplemental agreement No. 1 with Burns and McDonnell Engineering Company related to construction phase services for the West Parking Lot Improvement project at Columbia Regional Airport.

#### Discussion

On January 6, 2025, Council adopted Resolution 8-25 authorizing an aviation project consultant agreement with Burns and McDonnell Engineering Co., Inc. related to the design of the West Parking Lot Resurfacing project at the Columbia Regional Airport. This project includes demolishing the existing parking lot surface including aggregate and asphalt; construct a new asphalt parking lot with curb and gutter west of Airport Drive; new access drive to the parking lot from Airport Drive; pavement markings, signage and lighting.

Design services have been completed and the Purchasing division has received bids for the construction of the project. Staff is now requesting Council authorize the City Manager to execute Supplemental Agreement No. 1 with Burns & McDonnell Engineering Company for construction phase services in the amount of \$99,850. The FAA will reimburse the city 90% of this amount.

Short-Term Impact: The cost for construction phase services is \$99,850. The FAA will reimburse the City 90% of this amount and the City's 10% local share will paid from Transportation Sales Tax.
