Executive Summary

Authorizing the City Manager to execute Amendment No. 1 to the professional architectural services agreement with Architects Design Group / ADG, Inc. for design services related to the construction of the Police Precinct/Municipal Service Center North Facility. The amendment is for a not to exceed amount of \$19,290.00.

Discussion

On March 6, 2017, Council authorized a professional architectural services agreement with Architects Design Group / ADG, Inc. for design services related to the construction of the Police Precinct/Municipal Service Center North facility. The scope of services includes the development of a detailed spatial needs assessment, site analysis, master planning, community outreach program implementation, and conceptual design.

Staff is requesting Council authorize the City Manager to execute Amendment No. 1 to the agreement with Architects Design Group / ADG, Inc. for services related to re-platting the property's existing subdivision lots to consolidate into one lot and to prepare the PD Development Plan to be in compliance with the City's development code. The cost for these additional services is \$19,290.00.

Fiscal Impact

Short-Term Impact: The amendment in the amount of \$19,290.00 brings the total not to exceed design contract amount to \$1,046,365.00, and is being paid from funds allocated from the 2015 Capital Improvement Sales Tax Ballot for this project. Long-Term Impact: Construction of the facility is estimated to cost \$7,262,500.
