Re: Setting a Public Hearing - Sanitary Sewer Rehabilitation #8 Project

## Executive Summary

Staff has prepared for Council consideration, a resolution to set a public hearing for September 7, 2021, concerning the Sewer Rehabilitation #8 Project. The proposed sanitary sewer system improvements will consist of rehabilitation of approximately 17,500 linear feet of sewer line. The estimated cost of this project is approximately \$1,650,000 and will be paid from the Sewer Utility Revenue Bonds approved in the 2013 ballot.

## Discussion

The scope of this proposed sanitary sewer system improvement project consists of rehabilitating sewer pipe and lateral connections to the main located in primarily three areas in Columbia. See the attached location map. Approximately 17,500 linear feet will be rehabilitated to repair structural deficiencies and to reduce Inflow and Infiltration (I&I) into the sewer main. The project is anticipated to begin in FY2022.

The proposed rehabilitation project is a continuation of annual efforts to repair existing sewer infrastructure and reduce I&I as part of the Wastewater and Stormwater Integrated Management Plan. Work includes lining approximately 17,500 linear feet of aging sewer main identified by Sewer Utility staff during routine operation and maintenance activities. Many of these pipes are cracked or broken, nearing the point of failure. Rehabilitation of these lines will reduce inflow and infiltration (I&I) and the occurrence of stoppages. Reduction of I&I is part of the ongoing effort to reduce the number of backups into buildings and sanitary sewer overflows. Rehabilitation of sewer mains could occur throughout Columbia. As shown on attached individual project graphics, three primary areas where several mains are proposed to be rehabilitated with this project include:

- Parkade area
- Lynwood Drive area
- Albert-Oakland Park area

Interested Parties (IP) meetings were held on July 1, 2021, July 8, 2021, and July 15, 2021 for the primary affected areas. Thirteen (13) people attended the meetings (not including staff). Staff communicated with others who were interested in the project but could not attend the meeting. The estimated cost for this project is \$1.65 million and will be paid from Sewer Utility Revenue Bonds approved in the 2013 ballot.



## Fiscal Impact

Short-Term Impact: Resolution estimate of \$1,650,000 to be paid from Sanitary Sewer Revenue Bonds approved in the 2013 ballot.

Long-Term Impact: Reduced impact to annual maintenance and operation costs.
