

NOTICE FOR PUBLIC COMMENT AND HEARINGS FY 2024 ANNUAL ACTION PLAN

The Columbia City Council will hold a public hearing on June 17, 2024 at 7:00 p.m. in the Council Chambers of City Hall, 701 E. Broadway, to consider the City's FY 2024 Annual Action Plan. Copies of the draft document are available at 11 N. 7th St., Columbia, MO and at <https://tinyurl.com/as3w2edb>. Public comments will be accepted until 8:00 A.M. on June 28, 2024. The final document will be submitted to the U.S. Department of Housing and Urban Development (HUD) for approval along with public comment received and responses to those comments. The City of Columbia receives Community Development Block Grant (CDBG) and HOME Investment Partnership (HOME) funding from the U.S. Department of Housing and Urban Development (HUD) according to its population, demographics and the federal formula for distributing funds. The City is required to submit an Annual Action Plan each year in order to receive funding. The FY 2024 Annual Action Plan identifies community development needs and funding priorities for FY 2024. The 2024 Annual Action Plan is the fifth year's plan for expenditure of funds in the five-year cycle. The City's FY 2024 funding includes \$1,014,084 in CDBG funds and \$473,214 of HOME funds. Proposed usage of CDBG and HOME activities for the FY 2024 plan period are listed below.
