Re: Issuance of a Liquor License to a Business Located Within 100 Feet of Church

## Executive Summary

An application has been made to the State of Missouri for the issuance of a liquor license to a business located at 807 Locust Street called *Café Poland by Iwona LLC dba Café Poland by Iwona*, which is within 100 feet of a church.

## Discussion

Section 311.080 of the Missouri Revised Statutes requires the applicant to obtain the written permission of the City Council before the Missouri Division of Alcohol and Tobacco Control will consider issuing a liquor license to this business. A business operating under the name Café Poland has existed at this location, under previous ownership. This license application is on behalf of a new owner.

City ordinances and codes do not require any buffer between schools/churches and establishments that sell alcoholic beverages. However, issuance of the Missouri liquor license requires the consent of the local government. Since 2017, Endwell Taverna, Silverball, Parks Amusement Cantina, Sagua La Grande Cuban Café, Brookside Poolside, and Fuzzy's Taco Shop received City Council consent.

Consent also shall not be granted until written notice has been provided to all property owners within 100 feet of the proposed licensed premises, at least 10 days prior to consideration of this resolution. Such notification has been provided and staff has not received any feedback as of yet.
