AN ORDINANCE

amending the FY 2023 Annual Budget for first quarter appropriation of funds in the City Utilities, Community Development, Public Works, Information Technology, and Police Departments; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2023 Annual Budget adopted by Ordinance No. 025123 is amended by appropriating the sum of \$50,000.00 in the City Utilities Department from Account No. 5510-351000 to Account No. 17410923-504990 for matching funds as part of the VW Settlement direct current fast charging installation project.

SECTION 2. The FY 2023 Annual Budget is further amended by appropriating the sum of \$11,000.00 in the Community Development Department from Account No. 1100-351000 to Account No. 11004030-504990 for Adopt-A-Spot beautification projects.

SECTION 3. The FY 2023 Annual Budget is further amended by appropriating the sum of \$1,100,268.16 from and to the following accounts to finalize and close out completed Public Works Department capital improvement projects and to provide funding for current capital improvement projects:

SECTION 6. The FY 2023 Annual Budget is further amended by appropriating the sum of \$30,000.00 in the Police Department from Account No. 1100-262101 to Account No. 11002141-502010 to establish a de-escalation defensive tactics program in the Police Department.

SECTION 7. This ordinance shall be in full force and effect from and after its passage.




