Re: Authorizing a Bid Call for Construction of the Grindstone Parkway Sidewalk Project

## Executive Summary

Authorize a bid call through the Purchasing Division for the construction of the Grindstone Parkway, Hyde Park Avenue to Norfleet Drive, sidewalk project. An Interested Parties (IP) meeting was held on April 26, 2023 and a public hearing was held on June 20, 2023.

## Discussion

The Grindstone Parkway sidewalk project will include the construction of a sidewalk on the south side of Grindstone Parkway, filling in the sidewalk gap between Hyde Park Avenue and Norfleet Drive.

This project will include the following:

- Construction of a 5-foot sidewalk, with 3-foot green space starting at the end of the existing sidewalk just east of Hyde Park Ave. and going to Veterans United Dr.
- Construction of new ADA compliant ramps and landings on the south side of the E Nifong Blvd./Grindstone Pkwy and Veterans United Dr. intersection.
- Construction of a 5-foot sidewalk, with 3-foot green space, from Veterans United Dr. to the existing sidewalk just west of Norfleet Dr., with some areas transitioning to a 6-foot sidewalk at existing back of curb.

No permanent sidewalk easements or temporary construction easements will be necessary for construction of the project. The estimated total project cost is \$290,000 and includes design and construction. The project will be funded with the ¼-cent Capital Improvement Program (CIP) sales tax. Construction is planned for summer of 2024.

## Fiscal Impact

Short-Term Impact: The total project estimate is \$290,000 and will be funded with the ¼ cent Capital Improvement Program (CIP) sales tax.

Long-Term Impact: Per ordinance, sidewalks are maintained by the adjacent property owner.
