Re: Authorizing a Special Event Operations Agreement with FPC Live, LLC for the Central

Bank Downtown Live outdoor concert.

#### Executive Summary

This resolution authorizes the operations agreement for three outdoor concerts on June 28, July 12, and October 9, 2024 in downtown Columbia on Ninth Street outside The Blue Note located at 17<sup>th</sup> N. Ninth Street.

#### Discussion

FPC Live, LLC (dba The Blue Note) has submitted a special event application for three concerts on Ninth Street as a part of the 2024 Central Bank Downtown Live series (formerly known as Summerfest). The concerts are ticketed events with gates opening at approximately 6:00 p.m. and the concert ending at approximately 11:30 p.m. Attendance at the event is approximated at 3,000 peak.

No Thru Traffic signage will be placed at Ninth & Broadway, with channelizers in the north turn lane on Broadway. All alleys and points of egress will be blocked with a combination of bike rack barricades and snow fencing and vehicular barricades. All barricades to block streets will be compliant with the Manual on Uniform Traffic Control Devices (MUTCD).

During the set up off-duty officers will assist with directing traffic to and from Simmons Bank and Commerce Bank north on Ninth Street. Pedestrian traffic will be allowed until 4:30 p.m. at which point they will be directed to the main entrance at the north end of the block at Ninth & Walnut.

The Operations Agreement provides that the City Council's approval of the Operations Agreement will constitute council's approval of the exclusion of the closed locations from the open container ordinance. Pursuant to Section 16-258.1, this specific noise ordinance does not apply to sounds generated in compliance with an event or activity for which the City Council has authorized a street closure.

The Special Events Committee will continue to work with the organizers prior to the start of the event, including a walk-through inspection to ensure all aspects of the Operations Agreement are met and approved by the appropriate city staff.
