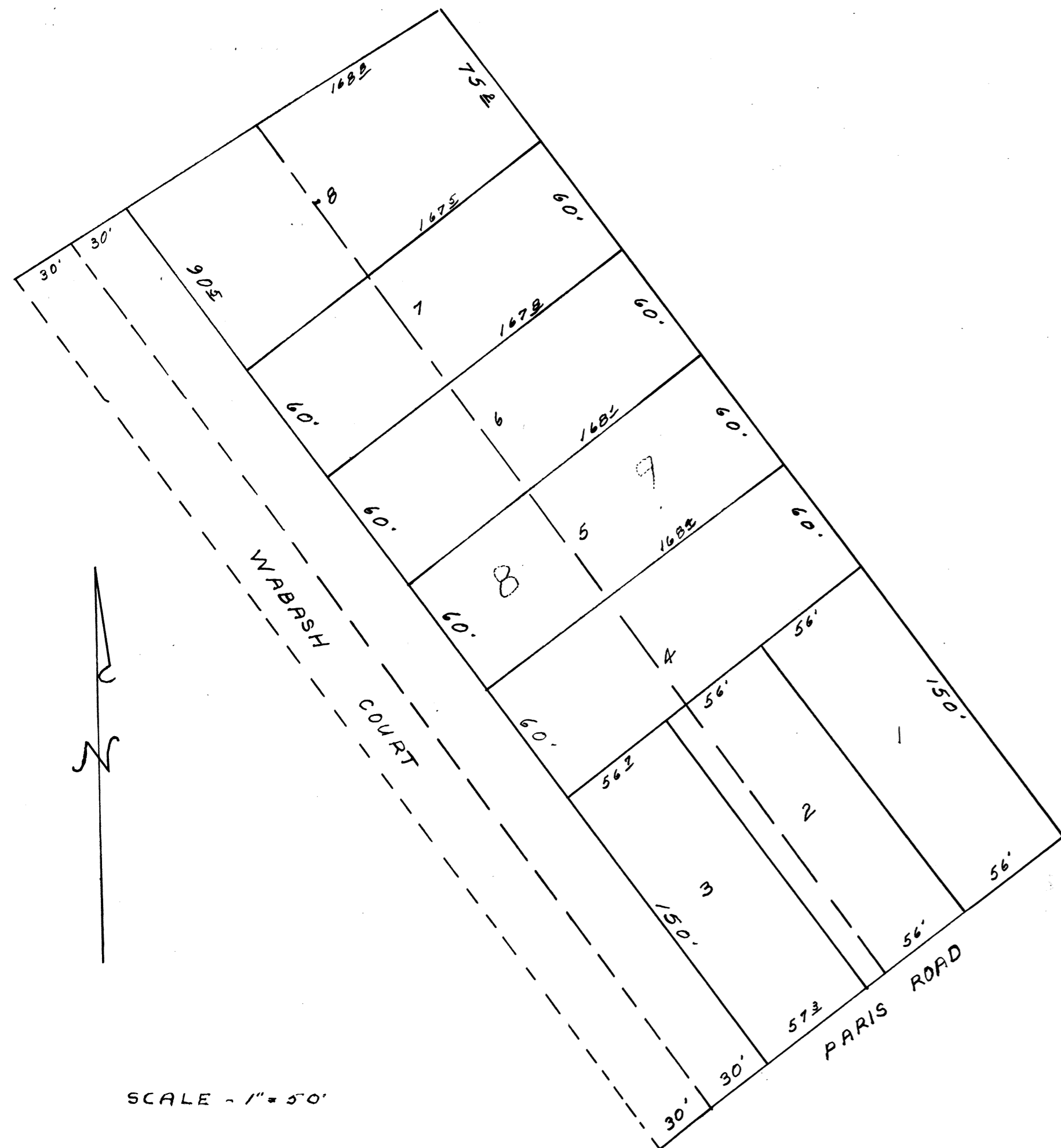


SUNNY SLOPE


