Re: Adopting Changes to the City of Columbia Strategic Plan

#### **Executive Summary**

Staff are proposing changes that would allow the City's Strategic Plan to be more readily updated. This proposed change would maintain required Council approval on any change to the Vision, Mission, Core Values, Priority Areas, and Goal Statements included in the Strategic Plan, but would allow modifications to the outcome objectives, performance measures, and action items to be done administratively. These changes would be reported out to Council during quarterly Strategic Plan updates. In order to accomplish this, staff recommends adopting a policy resolution that establishes a vision statement, mission statement, core values five strategic priority areas, and rescinding prior resolutions related to the 2021 Strategic Plan.

#### Discussion

Currently, the City's Strategic Plan requires a Policy Resolution for any modifications, including changes to performance measures and action items. As City Council sets the policy for the City, their guidance and oversight on the City's strategic priorities, vision, mission, and core values are necessary. Minor changes or updates to the outcome objectives, performance measures, and action items included under each of those strategic priority areas would benefit as an administrative function. This would allow those measures to be more quickly adapted, then reported out to City Council.

In order to make this change, staff propose a policy resolution that establishes a vision statement, mission statement, core values and five strategic priority areas. In addition, prior policy resolutions related to the 2021 Strategic Plan would be rescinded.

While much of the language would match language included in the Strategic Plan Highlight Report from January 2025, staff are proposing some changes to ensure compliance with Executive Order 14173. This would modify our Vision, Mission, and Core Values.

The proposed language for these areas are as follows:

**Vision:** Columbia is the best place for everyone to live, work, learn and play.

**Mission:** To serve the public equitably through democratic, transparent and efficient government.

#### **Core Values:**

<u>Service</u>: We exist to provide the best possible service to all.
