I support traffic calming being installed on Hanover Blvd. I have twice been passed on Hanover Blvd while going 30 by traffic coming from the Rice Road area. I think speed humps or squares are the best option. Lights along the southern most part of Hanover, between Clark and Hanover Estates, is needed as well as many people in electric wheelchairs travel to Dollar General at night and use the bike lanes, crossing the road at random places. Children live along Hanover Blvd and regularly appear unattended to and could run into the street at any time. Olympic Blvd is likely to need speed humps (and a large one at the Olympic/Hanover intersection) to slow traffic. I also support a roundabout at Clark/Hanover as well as at Olympic/Hanover if feasible instead of a speed hump.

I would also like Kid Friendly speed limit signs on Charleston Cir at both the N and S entrances.
