Re: Agreement with Regional Health Care Clinic, Inc dba Katy Trail Community Health for an Expanded HIV Testing Program.

Executive Summary

A resolution authorizing the City Manager to sign the agreement and Business Associates Agreement between the City of Columbia and Regional Health Care Clinic, Inc dba Katy Trail Community Health, allowing for collaboration on the execution of beginning an Expanded HIV testing program. This agreement shall be in effect until May 31st 2027 and may be renewed for two successive terms of one year.

Discussion

The Expanded HIV Testing Program supports healthcare entities in implementing routine opt-out HIV testing. The rapid HIV test kits, technical assistance, staff training, and linkage to care will be provided by Public Health and Human Services (PHHS) staff. By integrating HIV testing into standard medical care, the program works to make HIV screening a normal part of healthcare delivery. This program strives to provide early diagnosis and timely connection to treatment to improve health outcomes while preventing further HIV transmission within the community.

PHHS offers the Expanded HIV Testing Program within the 37 county Central Missouri Region as part of PHHS' High Impact HIV Prevention and Surveillance Programs agreement with Missouri Department of Health and Senior Services (Council Bill No. B21-25). Any associated costs are covered by the High Impact HIV Prevention and Surveillance agreement with Missouri Department of Health and Senior Services.
