We are writing to express our support for designating Columbia as an LGBTQ Sanctuary City. We are parents of two sons: a trans young adult, and a gay teen. This year has been exhausting for families like ours. When it looked like our trans son's health care was in jeopardy, we seriously investigated moving to a safer state. We ended up choosing to stay (for now) once we found out that he would still be able to access care since he is no longer a minor. Unfortunately, we know many families with trans kids who were not so lucky.

Now that our older son has finished school, he plans to move to Kansas City, in large part because of the proactive stance KC city officials have taken against the anti-LGBTQ rhetoric coming from Jeff City.

We believe that a diverse populace helps enrich Columbia and makes it a better place to live. The attacks on the LGBTQ community this year have been shocking and demoralizing—our younger gay son has faced much more bullying at school than his older brother did just a few years ago—and we fear with 2024 being an election year, it's only going to get worse. Please do the right thing and let people like our sons know that they are valued and welcome here.

My name is Jen Harper and I am a resident of Columbia, Missouri. I have been a public servant and worked for the state for over 20 years. I am also a coordinator for the Parents for Parents group at the Center Project, which is a group for parents, family, and caregivers of LGBT individuals.

I believe that it is important to support this ordinance.

We need to protect our community. For years we have had families and individuals who have moved to our community because we are a safer community for LGBTQ individuals. But in the last few years we have moved in the other direction. I know many families that have left Missouri, lifelong Missourians that have to leave their home state to protect their family. We need to stop the flight out of Missouri to more LGBTQIA friendly states.

As a parent of a college age child that identifies as LGBTQIA a lot of thought goes into whether particular schools are safe. Other parents are discussing academic programs and activity opportunities but parents like myself are trying to choose a college where my child is physically safe. I am the member of a national parent group of LGBTQIA children and there are lots of discussion threads on this topic. There are almost 40,000 parents in this group and right now Missouri does not fare well in this discussion. We need to turn this around, I would love be able to tell parents they should send their kids to Columbia, but I can't right now. Having 3 colleges in a sanctuary city would be a huge step to draw in these kids.

For the reasons stated in the proposal, I ask that you vote to recommend that the city council pass this ordinance.
