RESOLUTION NO. 2017-1

A RESOLUTION OF THE BUSINESS LOOP COMMUNITY IMPROVEMENT DISTRICT TO REVISE THE TERMS OF THE BOARD OF DIRECTORS TO REFLECT THE VOTER-APPROVED PETITION TO ESTABLISH THE DISTRICT AND REFLECT BEST PRACTICES FOR GOVERNMENT AND NON-PROFIT AGENCIES.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BUSINESS LOOP COMMUNITY IMPROVEMENT DISTRICT AS FOLLOWS:

WHEREAS, the Business Loop Community Improvement Development District (the "District"), which was formed on April 20, 2015, by Special Ordinance No. 022415 (the "Ordinance") of the City Council of the City of Columbia, Missouri, is a political subdivision of the State of Missouri and is transacting business and exercising powers granted pursuant to the Community Improvement District Act, Sections 67.1401 through 67.1571, RSMo ("CID Act"); and'

WHEREAS, the voter-approved petition to establish the Business Loop Community Improvement District requires "the Board of Directors will have a staggered term such that approximately one-third (1/3) of the Board of Directors is up for appointment every year"; and

WHEREAS, best practices for government and non-profit agencies recommend staggered terms to encourage greater participation from members, promote diversity, and encourage fresh perspectives; and

WHEREAS, best practices for government and non-profit agencies recommend staggered terms to preserve institutional memory; and

WHEREAS, best practices for government and non-profit agencies recommend regularly and periodic staggered terms to increase oversight and prevent mismanagement.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BUSINESS LOOP COMMUNITY IMPROVEMENT DISTRICT, AS FOLLOWS:

- 1. The District hereby institutes a policy of staggered terms as outlined in Appendix A.
- 2. This resolution shall be in full force and effect from and after its passage by the Board of Directors.
