Briefly describe the purpose of your request and explain what the expected benefits are:

L-TRON OSCR360 is a photography system designed and built for public safety. The high resolution capture kit includes a *360-degree spherical image camera and accessories, along with the supporting software.* The OSCR360 is used for documenting various scenes ranging from the most involved fire scene investigations to the simple municipal code violations. The OSCR360 assists investigators with documenting scenes and capturing photographic evidence more quickly and efficiently. The OSCR360 software allows users to provide a virtual walkthrough of the scene, connect evidence to where it was discovered, and give additional context to the investigation. The viewer software is also available to councilors and in courtrooms to describe the scene for trials. OSCR is used for fire scene investigations, fire service training, emergency management planning, active shooter training, forensic science curriculum, environmental safety, and more. The Columbia Fire Department assets are commonly called to assist agencies statewide with complex scenes and investigations. We will use the OSCR360 camera similar to our Arson Detection Canine when a fire marshal is requested to assist with an investigation.
