Re: Authorizing A Special Event Operations Agreement with FPC Live, LLC for a Central Bank Downtown Live outdoor concert.

Executive Summary

This resolution authorizes the operations agreement for an outdoor concert on October 2, 2025 in downtown Columbia outside The Blue Note located at 17 N. Ninth Street. Per Section 24-73(b) of the City Code, an agreement must be executed between the City Manager and Organizer because of the street closures and requirements of city services, equipment or support that is outside the ordinary course of business of the city.

Discussion

FPC Live, LLC (dba The Blue Note) has submitted a special event application for an outdoor concert on Ninth Street as a part of the 2025 Central Bank Downtown Live series. The concert is a ticketed event with gates opening at approximately 6:00 p.m. and the concert ending at approximately 11:00 p.m. Peak attendance at the event is estimated at 3,000.

Ninth Street will be closed from Broadway to Walnut. No Thru Traffic signage will be placed at Ninth & Broadway, with channelizers placed in the north turn lane on Broadway. All alleys and points of egress within the closure will be secured with a combination of bike rack barricades, snow fencing and vehicular barricades. All street barricades will be compliant with the Manual on Uniform Traffic Control Devices (MUTCD).

During set up, off-duty officers will assist with traffic flow for Simmons Bank and Commerce Bank. Pedestrian traffic will remain open until 4:30 p.m. at which time they will be directed to the main entrance at the north end of Ninth at Walnut.

The City Special Events Committee has been working with the Organizer to address all aspects of the event and its impact to the city. This includes event layout, street closures, parking & traffic plans, emergency & public safety plans, food service & alcohol management plans, utilities, solid waste plan, and insurance. The committee will continue to work with the organizer prior to the start of the event, including a walk-through inspection, to ensure all aspects of the Operations Agreement are met and approved by the appropriate City staff to ensure a safe and successful event.

The City Council's approval of the Operations Agreement will also serve as approval for excluding the closed location from the open container ordinance and downtown area noise ordinance.
