Re: Improvements to the Sanford-Kimpton Building

#### **Executive Summary**

A resolution authorizing the City Manager to sign the agreement between the City of Columbia and Michael K. Swim Architect, dba SSC Architects, Inc.

#### Discussion

Public Health and Human Services (PHHS) has been housed at the Sanford-Kimpton building at 1005 W. Worley since May, 2004. At that time, PHHS had approximately 65 employees. PHHS now has 104 employees. In order to accommodate this growth, PHHS has undertaken a renovation project which is being implemented in phases. This project will reconfigure the existing square footage to increase space for up to 121 employees. Safety and security for staff and customers will also be improved by enhancing the safety of customer reception areas and by further restricting public access to clinical and staff areas.

Michael K. Swim Architect, dba SSC Architects, Inc. was selected based on established procedures and guidelines for procurement of professional services as per City Ordinance 015992 and RFQUAL 183/2023.

The expenses associated with this agreement will be fully offset by funding from a contract with the Missouri Department of Health and Senior Services.
