Columbia Regional Airport

Executive Summary

Staff is requesting that Council authorize the City Manager to execute a fifth supplemental agreement to an airport aid agreement with MHTC relating to air service promotion for Columbia Regional Airport.

Discussion

On August 19, 2019, Council Bill 222-19 was passed authorizing the City Manager to execute an airport aid agreement with MHTC in the amount of \$250,000 relating to air service promotion for Columbia Regional Airport.

On July 6, 2020, Council Bill 128-20 was passed authorizing a first supplemental agreement to the airport aid agreement with MHTC to allow for \$150,000 of the original \$250,000 grant to be used in support of marketing new air service. The first supplemental agreement also extended the project period to August 1, 2021. At staff's request, Council authorized a second, third and fourth supplemental agreement extending the grant agreement one additional year each time.

Staff is now requesting that Council authorize the City Manager to execute a fifth supplemental agreement with MHTC to extend the project period from August 1, 2024 to August 1, 2025, to allow staff time to continue to work toward securing new service. A request for Council to approve the amendment along with an explanation and request that all actions taken by city staff prior to execution of the amendment be ratified.
