### Rollins Road Traffic Calming

Regarding the check box on the provided form: *I do NOT support most of the traffic calming projects I have seen implemented in Columbia.*

My wife and I have lived at the corner of Rollins Road and Sunset Drive since 1991. Traffic has increased virtually everywhere in that period. The increase at our corner has been gradual and I do not view it as a recent problem. On two occasions (that I know of first hand), drivers that were probably impaired, speeding, or both left Rollins, crossed the sidewalk and ended up nosing into the steep slope in the drainage easement between our yard and the road. Trees and brush (I doubt if good driving deserves credit) prevented the cars from continuing down another ten feet or so to the bottom of the easement.

From our property, we frequently see and hear vehicles traveling well over the posted 25 miles per hour speed limit and see many run the STOP signs (3-Way) at our corner. These violations of posted signage occur at all hours of the day and night. The traffic flows both ways on Rollins and the section of Sunset that intersects West Boulevard across from St. Andrew's Lutheran Church carries most of the traffic beyond the end of Rollins where it intersects Sunset.

Since there are STOP signs at the Intersection at our corner, drivers that do not stop are breaking existing laws. Since there 25 mph speed limit signs on both Sunset Drive and Rollins Road, drivers that are going faster are breaking existing laws. Even though school busses stop across from our house and even though the 'un-calm' traffic is a recognized problem I do not remember ever seeing a Police presence near our corner devoted to enforcing existing traffic laws.

As I think of traffic calming measures that have been implemented in Columbia I will mention three examples that I think range from terrible to OK. Starting with the worst, I think the 'improvements' made to Manor Drive between Rollins Road and Broadway are terrible. The many visible tire scrapes on the curb attest to the unnecessary problem drivers have navigating the intentionally unfriendly route. The added reflective posts seem to add insult without preventing injury. This design seems to have the goal of reducing, rather than calming, traffic. While it is probably effective in slowing down vehicles, it certainly doesn't calm drivers.

The recent work done on Stewart Road is simpler, but still unsatisfactory in my opinion. The plan there is very inconsistent. The posted speed limit remains 30 mph. The cautionary signs for the humps recommend 20 mph. The humps themselves seem to be engineered for a speed well below 20. When I drive Stewart Road, I am constantly varying my speed between about 15 mph and 30 mph. This is mechanically inefficient and psychologically frustrating.

My third and most acceptable example is Kelsey Drive between Lake of the Woods Road and Shamrock Drive on the far east side of Columbia. The posted speed is 25 mph. The speed bump cautionary signs recommend 25 mph (one says 20 mph). Crossing the bumps at the recommended speed is definitely bumpy, but does not seem likely to cause mechanical damage to the vehicle or stimulate frustration in the law-abiding motorist.

All of the traffic calming ideas discussed are aimed at interfering with driver's ability to get from one place to another by making the roadway more difficult to travel. My fourth option, which was more or

less rejected when I mentioned it at the meeting at Russell Boulevard Elementary School is to actively enforce existing traffic laws. Law enforcement presence and substantial fines, especially for repeat offenders, would provide benefits for public safety without interfering with traffic capacity. Additionally it would contribute to instilling in the driving public a sense of responsibility to obey existing laws.

If the proposals under consideration for calming traffic on Rollins Road are anything like the ones recently implemented on Stewart Road or Manor Drive I will be adamantly opposed to making the changes. If the plan eventually proposed is more like the one on Kelsey Drive, my position will fall somewhere between passive disapproval and luke-warm support. I strongly support enforcing existing laws.

I support traffic calming installation on Rollins Road with some exceptions.

### Bulbouts

My first preference would be to see bulbouts installed at the intersections of Rockcreek/Rollins as well as Colgate/Rollins to slow traffic going up and down the hill. I also think bulbouts would be beneficial at College Park/ Rollins and Russell/Rollins to increase safety for children crossing the street to go to school.

### Speed tables/humps

I have been reading about speed tables/humps and have concerns about those being installed. Sound is amplified in this valley and the noise those speed tables create could be considerable.

I am also concerned about the angle of the street and what that would be like for cars to hit speed tables while traveling too fast down hill. Could that create a larger safety issue?

For these reasons I do not support the installation of speed tables/humps on this road.

### Other ideas

An idea I would be interesting in seeing at these intersections is painted crosswalks and a center line to break up the visual emptiness of the road and bollards to see if future funding for bulbout is warranted.

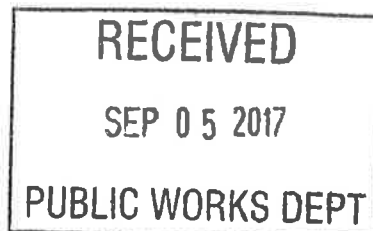

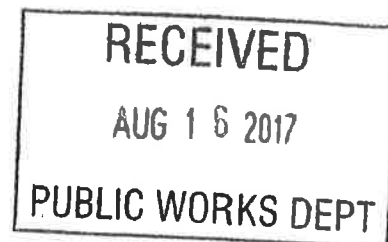

Dear Mr. Ray,

This is in regard to the Rollins Road Traffic Calming. I live on Rollins Road and I see no need for any traffic calming procedures like speed bumps that have been installed on Stewart Road.

Since the early spring closure of Rollins Road for the new culvert construction at Rock Creek the amount of traffic has greatly lessened. People just found other ways besides using Rollins Road. Those have made the number of cars using our street to be greatly reduced. Sometimes five or more minutes will elapse with no cars at all.

Other things to consider are a speed bump would endanger bike riders who zoom down the rather steep hill in front of my home. I can see a rider losing control of his or her bike and crashing. They would become airborne and lose control. So in closing I see no problems with Rollins Road and the so called speeding cars. I have noted carefully that out of 100 cars only one or two would deserve a speeding ticket. Most drivers who use our street are careful drivers and any speed bumps would just annoy the heck out of them.

I will be at the meeting on August 23rd and look forward to expressing my views in no uncertain terms.

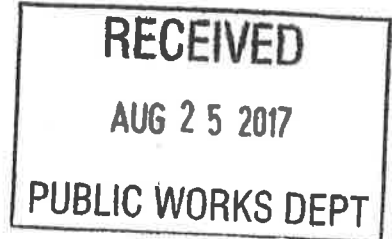

Dear Mr. Ray:

Thank you for your excellent presentation to the public this past Wednesday. It was clear and complete, and thank you for your willingness to patiently respond to questions.

**I STRONGLY support the installation of calming on Rollins Rd.**

We live near Rockcreek and Rollins. Traffic down the hill regularly exceeds 40 miles an hour, and occasionally people go close to 60. If you doubt this, please leave a monitor out for a two week period.

Our concern is that, wrongly placed, traffic calming may interfere with snow plowing, and might even cause the loss of control of a car, if the car is traveling at a high rate of speed, and the driver is unaware. I wonder if near the bottom of the hill, near the culvert, might be a relatively safe and effective place to install a speed bump or table. Another option might be a pedestrian island at the top of the hill, at College Park. That intersection can sometimes be difficult to cross.

I look forward to attending the next presentation, and seeing what plans you devise.

Finally, it has been a very long time since we have seen any police presence in the area. I support our police, and know they are stretched very thin. However, I think stationing an officer in the area at random times would easily pay for itself in tickets.

In fact, I would go further and suggest we put a "raised crosswalk" (a combination of a speed hump and crosswalk, with lots of signage/paint) at both ends of each School Zone. I have used Stewart Rd since the humps were put in. I never did drive down the road at a high rate of speed, but now, to have to slow to 15 just for the hump...well, I just use Broadway. I don't think the intent was to overload Broadway, it was simply to slow down the traffic on Stewart.

I use Rollins often, and I rarely see a great deal of speeding, perhaps it happens at other times. But if humps were put in, Again, I'd just use Broadway if the humps were as extreme as the ones on Stewart.

But here is where I could get behind slowing traffic--how about putting a Stewart Rd type hump at each end of **all** the school zones? That's a place where a hump could really contribute to safety.
