Re: Approval of an Operations Agreement with FPC Live, LLC for the production of a Ninth

Street Summerfest event on October 11, 2019.

Executive Summary

Staff has prepared for Council consideration a resolution granting closure of Ninth Street from Broadway to Walnut under section 24-73 of the City Code for a special event extending the premises of The Blue Note. The resolution also grants a temporary waiver from the requirements of section 16-185 to allow possession and consumption of alcoholic beverages for the event.

Discussion

Mike Nolan, manager of The Blue Note, has requested the closure of Ninth Street from Broadway to Walnut to hold a 9th Street Summerfest on Friday, October 11, 2019. The closure is requested from 8:00 a.m. on Friday, October 11, 2019, until 1:00 a.m. on Saturday, October 12, 2019.

Mr. Nolan has also requested a waiver from the requirements of section 16-185 of the City Code. The waiver is requested from 6:00 p.m. to 11:00 p.m. on October 11, 2019. Mr. Nolan has estimated attendance for the event at 1,500.

Per section 24-73 subsection (b) of the City Code, the City Event Committee is not authorized to close a street the day of, or the day after, a University of Missouri home football game (...) any closures of this kind require an agreement negotiated by the City Manager, or designee, and the event organizer, and approved by the City Council.

An operations agreement has been negotiated to address the following areas:

- Event security
- Street closure
- Alcohol sales and consumption
- Event set-up and tear down

The City Event Committee has approved the application for this event pending Council approval. Conditions of approval have included use of barricades that are compliant with the Manual on Uniform Traffic Control Devices (MUTCD) to block the street and alleyways and procurement of required liquor licensing and liquor liability insurance.
