**AN ORDINANCE**

amending the FY 2019 Annual Budget to add positions to the Municipal Court to provide for increased costs due to changes in the administration of parking tickets; appropriating funds; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2019 Annual Budget adopted by Ordinance No. 023633 is amended by adding the following positions to the Municipal Court as follows:

- 1.00 FTE    1400 Administrative Technician            Grade B8    Non-Exempt
- 2.00 FTE    1005 Administrative Support Assistant    Grade B5    Non-Exempt

SECTION 2. The FY 2019 Annual Budget is further amended by appropriating the sum of \$46,235.00 from the General Fund Balance Account No. 1100-341000 in the following amounts to the following accounts:


