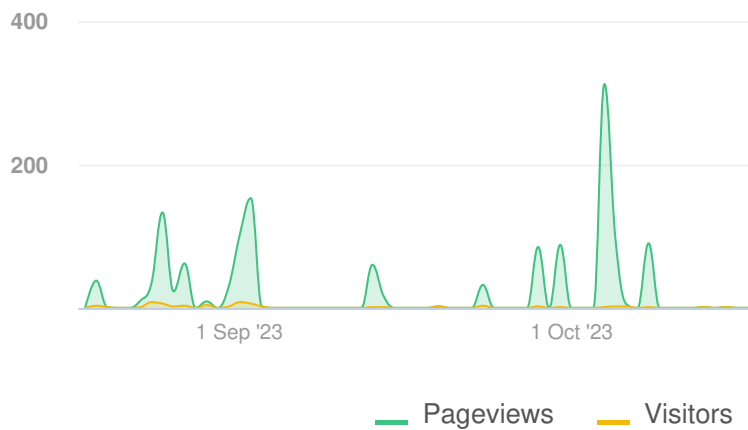

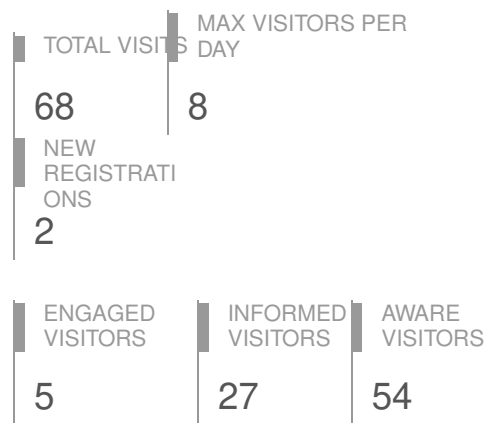

25 August 23 jacksonhotaling VOTES 1	<p>Please do not expand parking lot.</p> <p>The cycling station and amenities are an excellent idea, and would be a welcome addition to Stephens Lake Park. This would encourage more cycling. A parking lot expansion would do the opposite--green space needs to be green space.</p>
25 August 23 Camparan VOTES 2	<p>All new lighting to meet dark sky lighting standards and be in the red spectrum ((not over 3000K). Add EV charging station for cars too.</p>
31 August 23 Gloria VOTES 0	<p>Security cameras, especially in all parking lots. My car was broken into one bright sunny afternoon, also 2 other cars. Punched lock ~\$300.</p>
02 October 23 wright.matt.a VOTES 0	<p>Please stop adding so much parking to our parks!</p> <p>Dedicating additional space to parking reduces the amount of green space in parks, while incentivizing driving. We should be encouraging alternative forms of transportation, especially to and within our city parks. Increased pavement contributes to the heat island effect (which is already a significant problem, see the recent heat study done by the city), and incentivizing driving leads to an increase in greenhouse gas emissions (which we're supposed to be reducing - see every city plan that mentions climate). While many cities are converting old parking lots to parks, ours keeps adding too much parking to ours - disappointingly backward thinking for our supposedly progressive city. When I'm out trying to enjoy the natural beauty of our parks, I don't want to see a bunch of personal property all over the place! I do love the charging infrastructure and additional parking for bikes. If anything, add some charging infrastructure for cars too (at least incentivizing electric vehicles if you're going to incentivize driving) rather than adding yet more parking.</p>

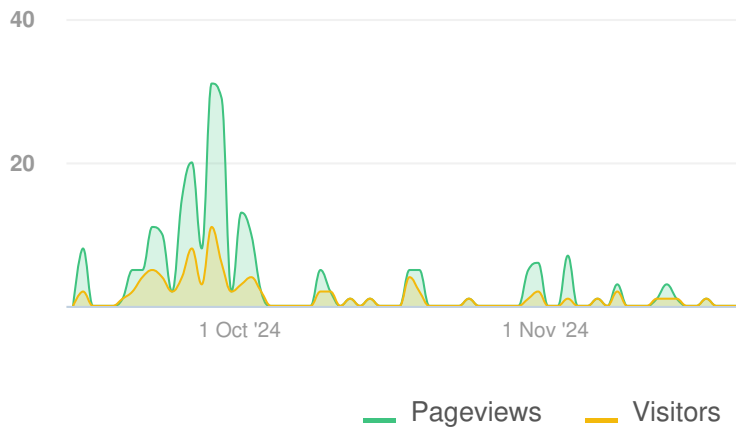

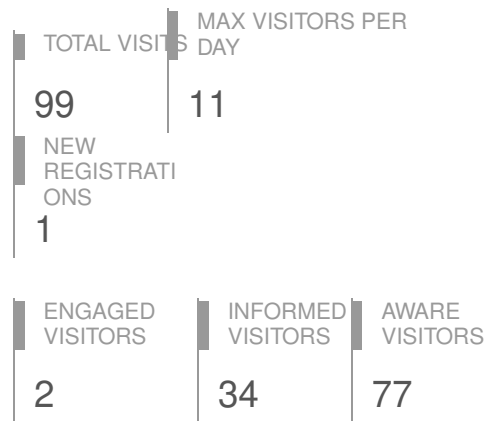
