Executive Summary

Authorizing an airport aid agreement with the Missouri Highways and Transportation Commission (MHTC) relating to air service promotion for Columbia Regional Airport; and amending the FY2026 Annual Budget by appropriating funds.

Discussion

The Columbia Regional Airport applied for and received an air service grant from MHTC in the amount of \$315,000 for air service promotion and marketing purposes, for the period January 1, 2025 through December 31, 2026. The grant requires a match of \$35,000 for a total project budget of \$350,000. The grant funding will be used for marketing COU to air travelers throughout the 17-county catchment area and in areas served by COU through a broad mix of radio, television, print, websites, and social media.

Staff is requesting that Council authorize the City Manager to execute the Airport Aid agreement with MHTC, and amend the FY2026 Annual Budget by appropriating funds.

Fiscal Impact
