Re: Missouri Department of Health and Senior Services Food Safety Assurance for Summer

Food Service Program and At-Risk Afterschool Program Site Inspections Agreement

Executive Summary

An ordinance authorizing the City Manager to sign the Missouri Department of Health and Senior Services Food Safety Assurance for Summer Food Service Program and At-Risk Afterschool Program Site Inspections. The agreement shall be effective through September 30,2024 with the reimbursement maximum of \$3,950.

Discussion

The Summer Food Service Program (SFSP) helps assure that eligible populations have access to nutritious meals during the summer months. When school is not in session, SFSP provides reimbursement to community agencies offering the required continuum of meals. The purpose of this agreement is to conduct food safety inspections and enforce expeditious correction of priority violations in food preparation and service at Summer Food Service Program and At-Risk Afterschool Program (At-Risk) meal production and meal services sites.

Missouri Department of Health and Senior Services will provide training to Environmental Health Specialists at Public Health and Human Services (PHHS) and will provide PHHS with the necessary information for all eleven (11) sites. PHHS will perform food safety inspections at identified sites. This legislation also ratifies the agreement which was authorized by the City Manager on 6/13/2024 due to the short nature of the summer food service program. The majority of the summer feeding sites end operations on 8/15/24.
