### **Executive Summary**

The City of Columbia is classified by HUD as an Entitlement Community and Participating Jurisdiction receiving both Community Development Block Grant and HOME Investment Partnership Program (HOME) funds. Participating Jurisdictions (PJs) receiving U.S. Department of Housing and Urban Development (HUD) entitlement grant funds must develop a Citizen Participation Plan (CPP) in accordance with Title 24 CFR 91.105 of the Housing and Community Development Act of 1974, as amended.

The attached resolution approves a minor amendment to the Citizen Participation Plan process to adjust dates and include an additional public engagement meetings within the process. Per federal guidelines and City CPP, only amendments resulting in a budgetary change of 10% or more or the elimination or addition of a new activity require a public hearing and "substantial amendment". The attached amendment will have not monetary impact, therefore, it is a minor amendment.

#### Discussion

The CPP is designed to encourage the participation of City residents in the development of the Consolidated Plan, particularly low to moderate income residents. The CPP also encourages local and regional institutions and other organizations (including businesses, developers, neighborhood groups and community and faith-based organizations) to participate in developing and implementing the 5-year Consolidated Plan and related reports.

City staff is amending the Citizen Participation Plan to match with amended and additional engagement meeting dates. These recommended changes are a result of additional input from community members and partnering organizations. The amended plan makes the following changes

- 1. The "Affordable Housing" engagement meeting from January 23rd to January 24th.
- 2. The Feb 13<sup>th</sup> REDI Board meeting replaces the "Economic Development" focus group originally scheduled for Feb 5<sup>th</sup>.
- 3. An additional engagement meeting for the topic of "Homelessness" has been added for Feb 19<sup>th</sup>.
