Speed Bumps In Front of Valleyview Park

First, I would like to say that the residents of Garden Drive appreciate the city listening to our concerns regarding excessive speeds witnessed on our street. My family lives directly in front of Valleyview Park. We have lived here for a few years now, and immediately realized the dangers that plague the street and the park due to the uncontrolled speed of neighborhood traffic. Very often, this section of road is treated like a drag strip, with cars and motorcycles violently accelerating, reaching speeds of what I would estimate to be about 60 MPH (the posted speed limit is 25 MPH). Families and children heavily utilize the park and the section of Garden Drive in front of it. We have witnessed far too many instances of close calls with pedestrians and park-goers exiting and entering their cars almost getting hit by vehicles flying up and down the road. I, myself, have had to yell out at drivers to slow down when I am simply trying to mow my yard, get the mail, or load our little girl into the car. The moronic driving continues all hours of the day and over night as well. With all of this being said, I believe 3-4 speed bumps spaced evenly in the section of street in front of the park would slow down traffic immensely. I would suggest against placing speed bumps only at either end of the park, as this would most likely cause vehicles to accelerate heavily between the two bumps, introducing another danger. We would be very open to hearing about traffic control measures that you think would be effective as well. Thank you again for your time. Traffic Calming And Pedestrian Safety

I'm very thankful for the support in making Garden Drive safer for residents and pedestrians. I believe that in addition to adding speed bumps, our neighborhood would benefit from adding curb extensions and a crosswalk to the intersection of Primrose and Garden. I also believe that we should extend the existing sidewalk on the north half of Garden which currently ends around Tulip Court. The proposed sidewalk should run south along the length of Garden Drive ending at Morning Glory Drive just before the hill (or beyond). The addition of a sidewalk would provide pedestrians a safe route to access the park. Add Roundabouts to some intersections on Garden Drive.

I know from experience running/walking along Garden Dr to Morning Glory drive people seem to speed up the hill with blind curve coming from Interstate 70 Dr NW to Garden Dr/Morning Glory intersection. I would like to see a roundabout at that intersection to slow drivers before they hit someone walking through the intersection. Primrose intersection is a similar situation with drivers going to/from Stadium blvd though it already includes a raised pavement which sort of helps but a roundabout or changing to a 4 way stop intersection would be better as larger trucks and SUV still speed over the raised pavement.
