Re: Authorizing the City Manager to Execute an Agreement with the National Collegiate Athletic Association for the 2027 NCAA Cross Country Midwest Regional Championships

### **Executive Summary**

The Columbia Convention & Visitors Bureau (CVB) and the Columbia Sports Commission partnered with the University of Missouri Department of Athletics to submit a bid to host the 2027 National Collegiate Athletic Association (NCAA) Division I Men's and Women's Cross Country Midwest Regional Championships. In October 2024, it was announced that Columbia had been selected as the host city. This resolution authorizes the City Manager to execute the agreement with the NCAA for this event.

#### Discussion

In 2023, for only the fourth time in its history, the NCAA conducted a site selection process in which most of its championships were open for bid at the same time. The CVB and the Columbia Sports Commission partnered closely with the University of Missouri Department of Athletics to prepare and submit a bid to host the 2027 NCAA Division I Men's and Women's Cross Country Midwest Regional Championships.

In October 2024, it was officially announced that Columbia had been awarded the event. The Columbia CVB will serve as a co-host, with Mizzou Athletics recognized as the official NCAA member institution host. Event execution will be a collaborative effort with the Columbia Sports Commission and Columbia Parks & Recreation.

In November 2023, the Columbia Sports Commission approved the allocation of Sports Development Funds toward the event, with the recommendation subsequently approved by the CVB Advisory Board later that month.

This NCAA event will take place November 12, 2027, at the Gans Creek Cross Country Course. The event is expected to bring over 500 athletes and thousands of spectators to Columbia, generating significant economic impact through hotel stays, restaurant dining, and retail shopping.
