The \$20,000 included ~~\$17,964~~ ^{\$17,984} in salary supplement for calendar year 2018 for John, leaving ~~\$2,036~~ ^{\$2,016} for other CFCM/City uses.

The Community Foundation Board of Directors voted at their August 27, 2018, meeting to provide a cost of living increase for John in the amount of \$1,444.35, to be paid in full by the end of December 2018. This will leave ~~\$591.65~~ ^{\$571.65} remaining for City use wherever needed.
