Recycling Center Improvement	N/A	Eric Kvam	<p>Contact has been made with the utilities department regarding the state of recycling centers in Columbia. The overflow of recycled items at particular recycling centers is cause for concern. Especially during times when students are moving in and out, the recycling centers overflow and produce waste. This issue was exemplified at The Armory location, where "stop-day" festivities caused an exponential increase in recycled items. Insufficient space in the recycling dumpsters caused the items to blow into the yards of nearby low-income apartments. This issue is undermining the CAAP strategy W-2.4 (Require and <b>Incentivize</b> recycling).</p>
