Re: Authorizing acceptance of award of the Nebraska Avenue Stormwater Improvements Project infrastructure grant with the Missouri Department of Natural Resources for State Fiscal Recovery Funds under the American Rescue Plan Act (2021); amending the FY 2024 Annual budget by appropriating funds.

# **Executive Summary**

Staff has prepared for Council consideration an ordinance authorizing the award of the Stormwater Improvements Project in the amount of \$619,660.60 from the Missouri Department of Natural Resources for State Fiscal Recovery Funds under the American Rescue Plan Act (2021). The ordinance authorizes the Grants Administrator, Andrew Wyatt, to sign the grant agreement and the appropriation of grant funds to eligible projects.

### Discussion

On June 6, 2022, Council passed Resolution 81-22 which authorized the Grants Administrator, Andrew Wyatt, to execute and file an application on behalf of the City of Columbia with the State of Missouri for American Rescue Plan Act Water Infrastructure Community Grant Programs through the Missouri Department of Natural Resources. The initial grant request was for drinking water, wastewater and stormwater infrastructure improvements. In November 2022, the Missouri Department of Natural Resources provided a notice of award for the following stormwater projects and funding amounts:

### Calvert Drive Detention:

Total Request: \$2,810,035.70 Local Cost Share: \$ 590,107.50 Grant request: \$2,219,928.20

#### Nebraska Avenue:

Total request: \$784,380.50 Local cost share: \$164,719.90 Grant request: \$619,660.60

### Storm Pipe lining:

Total request: \$1,008,159.81 Local cost share: \$211,713.56 Grant request: \$796,446.25

Once projects are bid, the MDNR will provide funding agreements. Attached is a copy of the grant agreement for the Nebraska Avenue Stormwater Improvement Project for review. This grant award, totaling \$784,380.50, includes a Federal portion of \$619,660.60 and a City match of \$164,719.90.

Rhad A. Baker Construction, LLC was the successful bidder for \$1,096,362.00. This bid includes \$209,575.00 for waterline relocation work and \$886,787.00 for the stormwater improvement project. The cost of waterline relocation and upgrades will be paid by Water Utility funds. The grant requires an 80/20 percent match. The City's 20 percent match and any additional required funding will be from Storm Water Utility funds. To be reimbursed with the MDNR ARPA funds, all construction must be completed by December 31, 2026.

### Fiscal Impact

Short-Term Impact: \$619,660.60 from MDNR ARPA funds; \$267,126.40 from Storm Water Utility funds; \$209,575.00 from Water Utility funds.

Long-Term Impact: Reduced impact on Storm Water Utility annual operating budget.
