A SUBDIVISION OF A PORTION OF A TRACT OF LAND DESCRIBED BY WARRANTY DEEDS RECORDED IN BOOK 722, PAGE 152 AND IN BOOK 896, PAGE 1, LOCATED IN THE SOUTHEAST QUARTER OF SECTION 16 AND THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 49 NORTH, RANGE 12 WEST, COLUMBIA, BOONE COUNTY, MISSOURI; AND DESCRIBED AS FOLLOWS:

STARTING AT THE NORTHEAST CORNER OF 21-49-12; THENCE WITH THE NORTH LINE OF 21-49-12, N89°18'W, 468.05 FEET TO THE POINT OF BEGINNING; THENCE S0°04'45"W, 257.7 FEET TO THE NORTH RIGHT-OF-WAY LINE OF PEABODY ROAD; THENCE WITH SAID NORTH RIGHT-OF-WAY LINE, N89°55'15"W, 748.2 FEET; THENCE CONTINUING WITH SAID NORTH RIGHT-OF-WAY LINE, N70°33'W, 257.25 FEET TO THE EAST RIGHT-OF-WAY LINE OF THE COLT RAILROAD; THENCE WITH THE EAST RIGHT-OF-WAY LINE OF THE RAILROAD, N24°03'45"E, 635.1 FEET; THENCE CONTINUING WITH THE EAST RIGHT-OF-WAY LINE OF THE RAILROAD, 414.45 FEET ON A 5779.65-FOOT CURVE TO THE LEFT (CHORD BEARS N22°00'30"E, 414.35 FEET); THENCE ON A NON-RADIAL LINE, S89°55'15"E, 578.0 FEET; THENCE S0°04'45"W, 792.3 FEET TO THE POINT OF BEGINNING AND CONTAINING 18.94 ACRES.

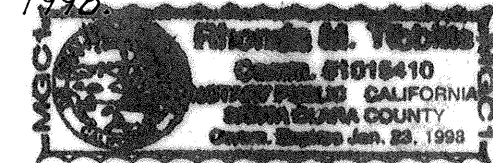

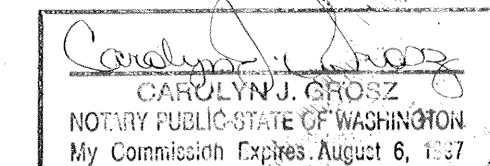
