

**AMENDMENT
to the
SOCIAL SERVICES PROVIDER AGREEMENT**

This Amendment to the Social Services Provider Agreement between the City of Columbia ("City") and Central Missouri Community Action ("Provider"), is made as of the date of the last signatory noted below ("Amendment Effective Date").

RECITALS

- A. WHEREAS, on December 22, 2020, City and Provider entered into an Agreement ("Provider Agreement") for personal finance education services; and
- B. WHEREAS, the Parties hereto desire to formally amend the Provider Agreement with this Amendment (hereinafter "Amendment") and desire to be bound by the terms contained in the Provider Agreement as amended by this Amendment.

AMENDMENT

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the Provider Agreement, as follows:

- 1. As of the Amendment Effective Date, Exhibit A is hereby removed from the Provider Agreement.
- 2. Section 1 of the Provider Agreement shall be removed and replaced with the following:
"1. Provider agrees to furnish and City agrees to purchase the proposed program service(s), for low-income residents of the City of Columbia, as set forth in Exhibit A1 attached to this Amendment at the rate set forth in Exhibit A1 attached to this Amendment.

The total allowable compensation for the Program Services under this agreement shall not exceed \$15,000.00 per year."

- 3. Section 4 of the Provider Agreement shall be removed and replaced with the following:
"4. PAYMENTS: Payments under this agreement will be made as follows:
 - a. Initial Payment. The Parties acknowledge that the City paid Provider \$10,555.98.
 - b. Final Payment. The City will pay the balance of the compensation due (\$4,444.02) upon receipt and approval of the year-end report."
- 4. All other terms of the Provider Agreement shall remain unchanged and in full force and effect.
