Re: Authorize an Airport Aid Agreement with Missouri Highway Transportation Committee (MHTC) and Appropriating Grant Funds

Executive Summary

Authorize the City Manager to execute an Airport Aid Agreement with Missouri Highways & Transportation Commission (MHTC) and appropriate grant funds related to the nearly completed reconstruction of Runway 13-31 and Taxiway C projects at the Columbia Regional Airport.

Discussion

In an effort to assist with financial aid related to the construction of a new terminal at the Columbia Regional Airport, MHTC has agreed to reimburse the City \$775,414.00, which is equal to fifty percent (50%) of the City's local match required from the Federal Aviation Administration (FAA) for the reconstruction of the Runway 13-31 and Taxiway C projects. Therefore, staff is requesting that Council authorize the City Manager to execute the Airport Aid Agreement with MHTC, and appropriate the grant funds to these capital projects.

The designation of this grant does not create a lump sum quantity contract, but rather only represents the amount of funding available for qualifying expenses. The release of all funding under the Airport Aid Agreement is subject to review and approval by MHTC of all project expenses to ensure that they are qualifying expenses.

Fiscal Impact

Short-Term Impact: A total of \$775,414.00 is being appropriated from the State Revenue Account as follows: \$612,321.58 to Runway 13-31 Project and \$163,092.42 to Taxiway C project.
