Re: Amendment No. 1 to Sidewalk Renovation Agreement with First Presbyterian Church for reconstruction of sidewalk along 16 Hitt Street

## Executive Summary

Authorizing the City Manager to execute Amendment No. 1 to the Sidewalk Renovation Agreement with First Presbyterian Church for reconstruction of the sidewalk along 16 Hitt Street. The agreement was approved by Council on August 4, 2025, per Resolution R110-25.

## Discussion

The First Presbyterian Church has requested assistance from the City to share the cost of repairing the sidewalk along 16 Hitt Street at the intersection with Cherry Street. The sidewalk is adjacent to the church property. The sidewalk improvements include removing and reconstructing existing sidewalk panels and curb ramp in order to improve Americans with Disabilities Act (ADA) accessibility.

The Church has obtained three bids to complete the improvements. The low bidder has contacted the church to let them know they were no longer interested in completing the work. Thus, the church would like to complete the work utilizing the second low bidder at a cost for replacement work for \$5,958.00. Once the sidewalk work is complete, the City will reimburse First Presbyterian Church 50% of the cost to repair the sidewalk with a not to exceed amount of \$2,979.00. Amendments No. 1 revises the reimbursement cost for the for the work completed by the second low bidder.

## Fiscal Impact

Short-Term Impact: The City's contribution to the cost share is a not to exceed amount of \$2,979.00. It will be funded with the 1/4-cent Capital Improvement Program sales tax.
