## AN ORDINANCE

vacating a portion of a sewer easement on Lot 327 within Wyndham Ridge, Plat No. 3 located on the south side of Steinbrooke Terrace (3804 Steinbrooke Terrace); directing the City Clerk to have a copy of this ordinance recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council finds and determines that a certain sewer easement on Lot 327 within Wyndham Ridge, Plat No. 3 located on the south side of Steinbrooke Terrace (3804 Steinbrooke Terrace), more particularly described as follows, is in excess and surplus to the needs of the City and is hereby vacated:

AN EASEMENT TO BE VACATED ON A TRACT LOCATED IN SECTION 4, TOWNSHIP 47 NORTH, RANGE 13 WEST, CITY OF COLUMBIA, BOONE COUNTY, MISSOURI, BEING PART OF A 16 FEET WIDE SEWER EASEMENT ON LOT 327 OF WYNDHAM RIDGE, PLAT NO. 3 AS SHOWN IN PLAT BOOK 48 PAGE 19 ALSO BEING PART OF THE TRACT DESCRIBED BY THE DEED IN BOOK 4588 PAGE 19 ALL OF THE BOONE COUNTY RECORDS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
