Re: Amend Chapter 17 of the City Code to Establish Fees for the Cross Country Course at Gans Creek Recreation Area

Executive Summary

The Parks and Recreation Department is requesting approval of an ordinance to amend Chapter 17 of the City Code to establish fees for the use of the cross country course and associated amenities at the Gans Creek Recreation Area.

Discussion

At the August 20, 2018 the City Council authorized the development of a cross country course at the Gans Creek Recreation Area. This legislation is to establish fees for the new facility and incorporate those fees in Chapter 17 of the City Code.

The proposed fees for use of the cross country course and associated amenities are outlined in the attached Proposed Cross Country Fees.
