Dear Patrick,

I am contacting you to express my support of the Neighborhood Protection Section (NPS) of the Unified Zoning and Subdivision Code. My husband, Gary Weisman, and I have been residents of the East Campus neighborhood since the mid-1980s and enjoy living in an older neighborhood that is a mixture of rental houses and owner-occupied homes.

In the past several years, there has been a trend in Columbia to build new expensive apartment complexes located within walking distance to the University of Missouri campus. As you might suspect, our neighborhood is viewed favorably by developers and just recently two older large homes were razed to make way for a new apartment complex by the Stephens College tennis court.

Part of the charm of Columbia is its older neighborhoods and, as the parent of three children who attended college, it always made me feel better to see my children living off-campus in a mixed neighborhood like East Campus. I knew that their social education would be enhanced by contact with home owners and not just other young student renters. The NPS helps to maintain mixed neighborhoods and avoids East Campus being turned into a student 'ghetto' of expensive student housing complexes.

We want to maintain the character of Columbia and our older neighborhoods are an integral part of that mix.
