Re: Memorandum of Understanding with Learning for Life, an affiliate of the Great Rivers Council, Incorporated, Boy Scouts of America to establish a Fire Explorer Post

Executive Summary

Staff has prepared a resolution for Council consideration authorizing the City Manager to sign a Memorandum of Understanding with Learning for Life, an affiliate of the Boy Scouts of America, allowing the Columbia Fire Department to reestablish the Fire Explorer Post.

Discussion

The Columbia Fire Department is committed to reestablishing its Fire Explorer Post, open to youth from Columbia and the surrounding areas. This hands-on program, available to individuals aged 14 to 21, is designed to introduce young people to first-responder practices and serve as a strategic recruiting tool for fostering diversity within our fire department. By actively engaging youth from all backgrounds, the Fire Explorer Program strengthens our commitment to creating a fire service that reflects the diverse community we serve.

Participants in the program don't just gain theoretical knowledge, they acquire practical life skills that are applicable in various personal and professional situations. These include teamwork, respect for themselves and others, accountability, and time management. The program also equips youth with essential trade-related skills such as ropes and knot tying, safe ground ladder use, hand tool operation, water emergency safety (ice rescue and warm water emergencies), CPR, fire prevention, and leadership.

Through this program, we aim to inspire the next generation of fire service professionals. But it's not just about the individuals, it's about the community. We want to emphasize the crucial role of community involvement in shaping a fire department that protects and serves everyone equitably.

This Memorandum of Understanding outlines the responsibilities of the Columbia Fire Department and participating members and the support services provided by Learning for Life.

Fiscal Impact

Short-Term Impact: \$5,000 is anticipated for uniforms and safety equipment.

Long-Term Impact: \$2,000 annually to replace equipment as needed.
