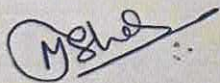

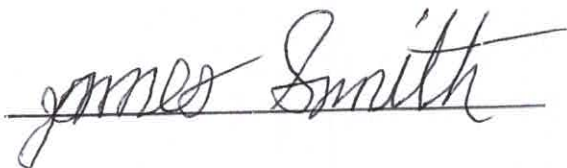
All of the neighbors in this area highly respect and appreciate all they do to keep their places looking nice and the neighborhood is blessed to have them managing property here.
