

**FIRST AMENDMENT  
to the  
CDBG GRANT AGREEMENT**

This First Amendment to the Agreement between the City of Columbia, Missouri, a municipal corporation (hereinafter the “City) and Independent Living Center of Mid-Missouri, Inc. (d/b/a Services for Independent Living), a not-for-profit corporation of the State of Missouri (hereinafter the “Agency”) is made as of the date of the last signatory noted below (“Amendment Effective Date”).

**RECITALS**

- A. WHEREAS, on or about December 16, 2024, City and Agency entered into a Community Development Block Grant (CDBG) Grant Agreement (“CDBG Grant AGREEMENT”); and
- B. WHEREAS, the Parties hereto desire to formally amend the CDBG GRANT AGREEMENT with this First Amendment (hereinafter “First Amendment”) and desire to be bound by the terms contained in the 2024 Agreement as amended or supplemented by those terms contained in this First Amendment.

**AMENDMENT**

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the 2024 Agreement, as follows:

- 1. Section 2) c shall be deleted in its entirety and replaced with following:  
  
“Agency agrees that all work shall be completed and funds expended by June 1, 2026.”
- 2. All other terms of the 2024 Agreement shall remain unchanged and in full force and effect.
