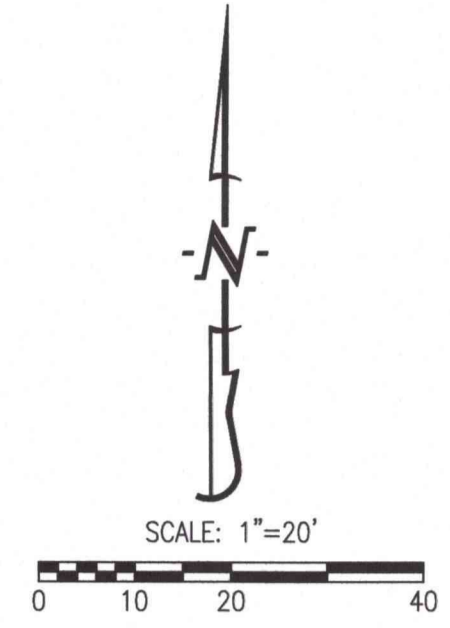


LOCATION MAP  
NOT TO SCALE



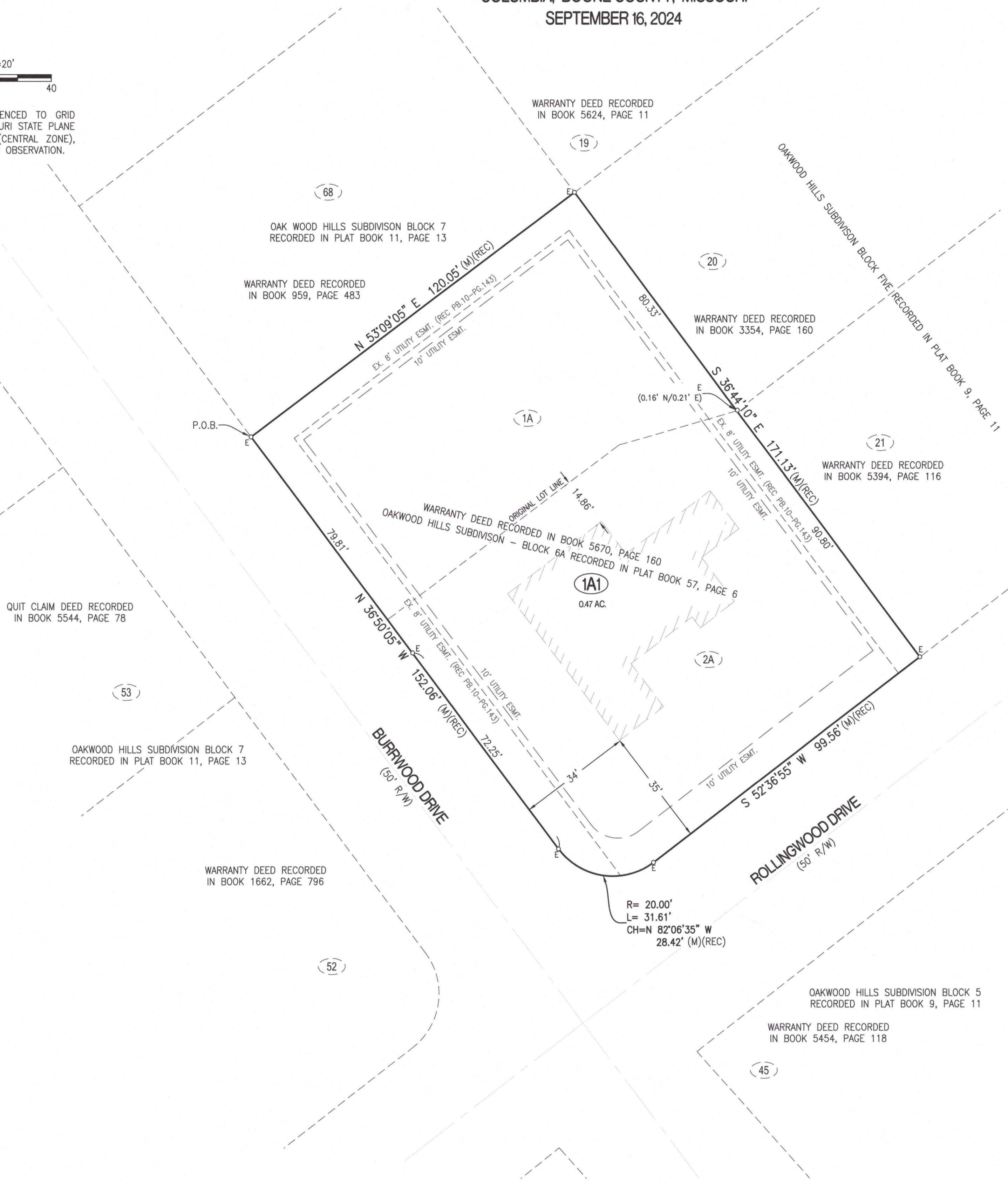

BEGINNING AT THE WESTERNMOST CORNER OF SAID LOT 1A AND ALSO BEING THE SOUTHERNMOST CORNER OF LOT 68, OAK WOOD HILLS SUBDIVISION, BLOCK 7, RECORDED IN PLAT BOOK 11, PAGE 13, SAID POINT BEING ON THE EASTERLY RIGHT OF WAY LINE OF BURRWOOD DRIVE AND LEAVING SAID EASTERLY RIGHT OF WAY LINE AND WITH THE NORTHERLY LINE OF SAID LOT 1A, SAID LINE ALSO BEING THE SOUTHERLY LINE OF LOT 68, N 53°09'05"E, 120.05 FEET TO THE EASTERNMOST CORNER OF SAID LOT 68, SAID POINT ALSO BEING THE SOUTHERNMOST CORNER OF LOT 19, OAKWOOD HILLS SUBDIVISION, BLOCK 5, RECORDED IN PLAT BOOK 9, PAGE 11, SAID POINT ALSO BEING THE NORTHERNMOST CORNER OF SAID LOT 1A; THENCE LEAVING SAID NORTHERLY LINE AND WITH THE EASTERLY LINE OF SAID LOT 1A AND EXTENDING ALONG SAID LOT 2A, SAID LINE ALSO BEING THE WESTERLY LINE OF LOTS 20 AND 21 OF SAID OAKWOOD HILLS SUBDIVISION, BLOCK 5, S 36°44'10"E, 171.13 FEET TO THE NORTH RIGHT OF WAY LINE OF ROLLINGWOOD DRIVE, SAID POINT ALSO BEING THE EASTERNMOST CORNER OF SAID LOT 2A; THENCE LEAVING SAID EASTERLY LINE AND WITH SAID NORTH RIGHT OF WAY LINE, S 52°36'55"W, 99.56 FEET; THENCE TRANSITIONING FROM SAID NORTH RIGHT OF WAY LINE TO SAID EAST RIGHT OF WAY LINE FOR BURRWOOD DRIVE, 31.61 FEET ALONG A 20.00-FOOT RADIUS TANGENT CURVE TO THE RIGHT, SAID CURVE HAVING A CHORD, N 82°06'35"W, 28.42 FEET; THENCE WITH SAID EAST RIGHT OF WAY LINE, N 36°50'05"W, 152.06 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.47 ACRES.

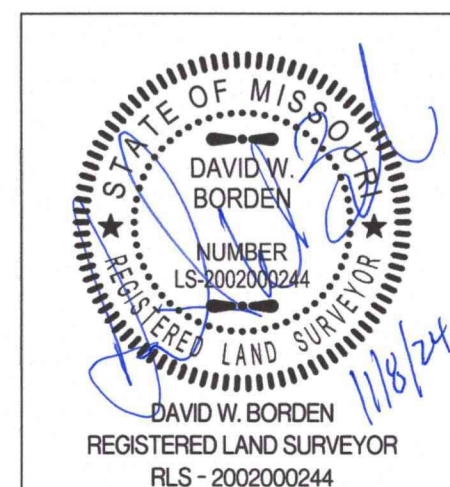
