COMMENCING AT THE NORTHEAST CORNER OF SAID LOT; THENCE SOUTH 89 DEGREES 18 MINUTES 00 SECONDS WEST (BASED ON THE "MISSOURI COORDINATE SYSTEM OF 1983", CENTRAL ZONE 2401, GRID NORTH AS DERIVED FROM THE MODOT VRS SYSTEM) ON THE NORTH LINE OF SAID LOT, ALSO BEING THE SOUTH RIGHT-OF-WAY LINE OF CALVERT DRIVE (60-FEET WIDE), 125.87 FEET TO THE POINT OF BEGINNING.
