Re: Vacating an Unused Trail Easement within the Hominy Trail Phase II Project

#### **Executive Summary**

Staff is requesting authorization to vacate an unused trail easement within the Hominy Creek Trail Phase II project. This easement was acquired in 2012 as part of the trail project; however, due to a re-design of a stream crossing, the easement is no longer needed.

#### Discussion

On December 3, 2012, Council passed Bill 330-12 authorizing the acquisition of easements for construction of the Hominy Creek Trail Phase II project. During construction of the trail, it was determined that the stream crossing would need to be re-designed, and a change to one of the acquired easements (Parcel 20) was necessary. The property owner was willing to dedicate the revised easement for the trail relocation. That revised easement was granted in May of 2016 (see attached) and Council Bill 212-16 was passed on September 6, 2016 accepting the easement. Staff is requesting to vacate the original easement acquired in 2012.
