Re: Setting a Public Hearing to consider the FY2022 CDBG and HOME Annual Action Plan

Executive Summary

Staff has prepared a resolution setting a public hearing for August 15, 2022 to consider the FY 2022 Annual Action Plan. The Plan reports how the funding Community Development Block Grant and HOME Investment Partnerships grant allocations will be used to achieve the goals outlined in the City's Consolidated Plan. Allocations within the FY 2022 Annual Action Plan were adjusted from estimated amounts originally included within the FY 2022 City budget to align with final allocations approved through the congressional budgeting process. A public hearing is required by the U.S. Department of Housing and Urban Development in accordance with the City's Citizen Participation Plan.

Discussion

Approval of the FY 2022 Annual Action Plan is required in order to receive CDBG and HOME program funding for FY 2022 projects. City staff was notified of final allocation amounts on May 31, 2022 (letter dated May 13, 2022): \$1,014,077 in CDBG and \$630,924 in HOME. Notifications of funding awards historically occur between January and May. The attached resolution approves setting a public hearing for August 15, 2022 in order to submit the FY 2022 CDBG and HOME Annual Action plan by August 16, 2022. Funds were allocated to projects and programs in 2021.

A draft copy of the FY 2022 Action Plan has been posted to the Community Development Department Housing Programs Division (HPD) webpage, circulated to Housing and Community Development Commission Members, and posted to the HPD Listserv and social media. A full report of the FY 2022 Annual Action Plan will be provided to Council prior to the August 15, 2022 hearing.
