## Executive Summary

Authorizing East 280 LLC to temporarily occupy two (2) parking spaces on the north side of Walnut Street, between Eighth Street and Ninth Street, to complete infill work at an office building located at 807 E. Walnut Street.

#### Discussion

East 280 LLC is seeking permission to temporarily occupy two (2) parking spaces on the north side of Walnut Street, between Eighth Street and Ninth Street, from March 5, 2019 to April 19, 2019, to complete infill work at a new office building located at 807 E. Walnut Street.

This temporary occupation of the parking spaces will generate a public inconvenience fee of \$648.60 (\$0.30 x 47 linear feet x 46 days). The fee will be collected prior to issuance of the certificate of occupancy. The contractor has contacted business owners in the area (see attached letter), and staff no issues with their request.

# Fiscal Impact
