AN ORDINANCE

amending the FY 2023 Annual Budget for first quarter appropriation of funds in the Parks and Recreation Department, Vehicle and Equipment Replacement Fund, Public Health and Human Services Department, and Finance Department; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2023 Annual Budget adopted by Ordinance No. 025123 is amended by appropriating the sum of \$100,000.00 in the Parks and Recreation Department from Account No. 4400-480000-00518 to Account No. 44008850-604990-00518 for construction of an indoor building at the Gans Creek Cross Country Course.

SECTION 2. The FY 2023 Annual Budget is further amended by appropriating donated funds in the amount of \$4,800.00 from the Show Me Pickleball Club provided to the Parks and Recreation Department from Account No. 23108554-480539 to Account No. 22005230-501100 for the installation of a shade structure at the Albert-Oakland Park pickleball courts.

SECTION 3. The FY 2023 Annual Budget is further amended by appropriating the sum of \$40,000.00 in the Parks and Recreation Department from Account No. 2200-411000 to Account No. 22005440-504990 to remove and replace components for the splashpad at Flat Branch Park.

SECTION 4. The FY 2023 Annual Budget is further amended by appropriating the sum of \$20,000.00 in the Parks and Recreation Department from Account No. 23108554-480539 to Account No. 44008850-604990-00703 for the Philips Park Trail and Landscaping Improvement Project.

SECTION 5. The FY 2023 Annual Budget is further amended by appropriating the sum of \$691,727.84 from the Vehicle and Equipment Replacement Fund (VERF) Account No. 6770-351000 for fleet purchases for the Police Department (\$103,925.06), Fire Department (\$27,462.00), Parks and Recreation Department (\$31,605.78), Streets and Engineering Division (\$318,979.00), Airport (\$5,571.00), Parking (\$9,573.00), and the VERF General Fund Pool (\$194,612.00) as follows:


